TERMS OF PARTICIPATION

1. All participants must read these house rules before entering the park. By signing, the participant confirms that they have taken note of and understood these house rules and undertakes to abide by them. For minors, the parent or legal guardian must read these house rules and discuss them with the minor before using any of the climbing routes. Instructions given by the staff present are to be followed at all times.
2. There are risks and dangers associated with using the climbing park. Participants engage in climbing activities at their own risk. Improper use of safety equipment and behaviours may result in serious injury or death. The participant acknowledges that it is not possible to rule out serious or even fatal injuries even if the utmost care is taken. Climbing routes (marked green and above) are open to visitors who are at least 110 cm tall, (mini/children's climbing routes are open to 4-year-olds and above) who do not suffer from an illness or a mental or physical impairment that could pose a risk to them or the other people when using the park. Children under 14 must be accompanied by an adult. The minimum height/age and any additional requirements for the individual courses (accompanying person) can be found on the notice board at the issuing office.
3. The maximum weight limit for participants is 120 kg.
4. Pregnant women may not participate.
5. Persons who are intoxicated or under the influence of drugs or medication or other substances that may impair their responsiveness are not permitted to use the climbing routes.
6. Eating food, chewing gum, drinking, etc. is prohibited. Smoking is prohibited throughout the premises.
7. No items may be taken onto the course. Please empty trouser pockets and any other pockets on clothing. Objects, loose objects in particular, can be a danger to the participant or others. This applies in particular to backpacks, jewellery, mobile phones, cameras etc. Throwing objects is strictly prohibited. Long hair must be tied back in such a way that it is not loose or can get caught in ropes, cable winches etc. The equipment we lend you (helmet, harness, safety lanyard with carabiner and steel pulley) must be used according to your guide's instructions. The items may not be swapped, given to others or taken off on the climbing route and must be returned at the end of the course.
8. Each participant must take part in the full practical and theoretical safety demonstration before entering the adventure park and complete the training course. All instructions and decisions of the organiser/guide are binding and must be adhered to at all times. In case of violations or if the instructions or safety requirements of a guide are ignored, participants may be asked to leave the climbing park. In case of violations or if the instructions or safety requirements of a guide are ignored, Spanische Hofreitschule - Lipizzaner Stud Piber GöR accepts no liability for any associated damages.
9. The safety carabiners must always be attached to the red safety rope. When re-clipping, only re-clip one safety carabiner at a time. The steel cable pulley must be attached to the green safety cable (Flying Fox route)! Before starting the Flying Fox route, you must ensure that the route and the landing area is clear! Each station may only be used by one person at a time. A maximum of 3 people may be on the platforms at the same time.
10. The participant acknowledges that injuries of all kinds are possible when using the climbing routes – irrespective of the house rules. Depending on the time of year, participants may get dirty for example due to resin on the trees or staining materials.
11. Management reserves the right to ask persons to leave the park who do not comply with these house rules. Any authorised person may request this.

12. Management reserves the right to cease operations due to safety concerns (fire, storms, thunder and lightning, etc.). In this case, there shall be no reimbursement of the entry fee. If the guest leaves the Adventure Park early of their own volition or because they have been asked to leave, they will not be entitled to a refund of the entry fee.
13. Spanische Hofreitschule - Lipizzanergestüt Piber GÖR is liable for personal injury in accordance with statutory regulations. Spanische Hofreitschule - Lipizzanergestüt Piber GÖR shall only be liable for property damage and financial loss in the event of intent or gross negligence on the part of the organiser or the person entrusted with the delivery of the event or guided tour. This limited liability is expressly consented to by signing the Terms of Participation
14. **GDPR – General Data Protection Regulation:** The participant consents to their personal data (name, address, email address) being stored for liability and warranty purposes. The participant consents to their personal data (name, address, email address) being processed for sending advertising materials, newsletters and ratings platforms. The participant agrees that photos and videos taken by staff at the climbing park during the activities may also be used by the adventure park for advertising purposes without further consent. **The participant has the right to revoke their declaration of consent at any time in accordance with legal regulations.**
